**Closing date** - 5:00 PM, Wednesday, May 15, 2019. Entries must be delivered to the Test Secretary by the closing date. The club cannot accept entries delivered after this date and time. After the closing date, the club will send out acceptance letters or emails, advising entrants of the status of their entry.

**Entries** must be mailed or sent by courier to the postal address of the event secretary. Faxed, e-mailed or hand delivered entries are not acceptable. Each entry must be mailed in a separate envelope. All entries received prior to the closing date will be acknowledged by mail/email, and entered in entry draw.

A random draw of all non-duplicate entries will be conducted at 7:00 pm on May 16, 2019 at The Barking Lot, 1299 Hanwell Road, suite 9, Fredericton, NB. Any interested parties may attend the draw. After the draw, the club will send out acceptance letters or emails, advising entrants of the status of their entry. Directions to the rendezvous site for the test will be provided.

Entries not drawn shall be assigned a position on an "Alternate List" in the order received. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. The person making the entry shall be notified of their position on the alternate list. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

**Closing date:** 5:00 PM, May 15, 2019.

Note: On the official closing date, if entries do not fill in a specific level of track, tests may be interchanged in accordance to CKC Rule 6.2.

These tests are open to mixed breeds and unrecognized breeds. According to CKC Rule 2.2.4: If a club chooses to accept entries from mixed breeds and unrecognized breeds, they will use the following procedure: Draw (1) Purebred dogs without a title; Draw (2) Purebred dogs with a title; Draw (3) Mixed breeds and unrecognized breeds without a title; Draw (4) Mixed breeds and unrecognized breeds with a title.

**Draw for tracks** (TD and TDX) on Sunday, May 26, will occur at 9:00 am at the rendezvous site: Tim Hortons, 1713 Woodstock Road, Fredericton, NB

**Awards / Prizes** - Passing dogs will receive a rosette and a suitable prize.

**Entry fees:** \$70.00 TD / \$90 TDX

**Listing fee** - \$11.50 "A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form."

**Fees** are payable to: **River Valley Obedience & Field Trial Club, Inc. (or RVO & FTC)**. Post-dated cheques will not be accepted. NSF Cheques will be considered non-payment of entry fees. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation is appreciated.

**Withdrawals and Entry Fee Refunds** - If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary.

Entries will be refunded within ten days of the tracking test to those on the alternate list who did not participate in the test. Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

**Bitches in Season** - Bitches in season **will** be allowed to participate but must run last and must be kept separated from all other dogs during the event.

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

River Valley Obedience & Field Trial Club will use all reasonable care to ensure the safety of dogs and persons at the test. However neither RVO&FTC nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

*CKC Tracking Rules (13.7): It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue*
